5th meeting of the Special Group of National Focal Points for the European Defence Fund

Brussels, 14 December 2022, 13:30-17:30

Summary Record

1. Introduction

The meeting took place in a hybrid format.

2. Points discussed

The members of the group addressed the following main items during the meeting:

• General update on EU security and defence initiatives: The Commission services provided an update on the recent defence-industry related initiatives, in particular the EU Policy on Cyber Defence, Action Plan on Military Mobility 2.0, and the European Defence Innovation Scheme.

Facilitating partner search & matchmaking

The Commission outlined a number of existing tools for partner search and matchmaking. The Enterprise Europe Network Sector Group Aerospace & Defence outlined its services and how it could support the activities of the NFPs. The European Defence Agency reported on its activities to support cross-border business and partnerships. The subsequent discussion centred on 3 questions: what tools do NFP use for partner search and matchmaking, what are their experiences with such tools and what further needs are not being addressed by the existing tools.

• Under a point on 'Exchange of best practices of NFP engagement with their stakeholders', LU NFP made a presentation outlining their experiences with EDF outreach.

3. AOB

The Commission replied to questions from the NL NFP regarding eligibility and indirect costs. The Commission also announced that it would launch a survey for NFPs in January.
