# **3<sup>rd</sup> meeting of the Special Group of National Focal Points for the European Defence Fund**

Brussels, 29 June 2022, 10:00-13:00 h.

## **Summary Record**

#### 1. Introduction

The meeting took place in a hybrid format.

#### 2. POINTS DISCUSSED

The members of the group addressed the following main items during the meeting:

- General update on EU security and defence initiatives: The Commission services provided an update on the recent defence-industry related initiatives, in particular the Joint communication 'Defence investment gaps analysis and way forward' adopted on 18 May 2022 and the EU Defence Innovation Scheme;
- Support to the National Focal Points network via EDF Work Programme 2022: The Commission provided detailed information about the EDF Work Programme 2022 call in support of the NFP network (EDF-2022-CSA-NFP). This was accompanied by a presentation from the coordinator of the Horizon 2020 National Focal Points project 'Bridge2HE' who shared his experience with the set-up and management of such projects, as well by an exchange of views with Member States.
- Under a point on 'Experiences of NFP engagement with their stakeholders', DK and CZ NFPs made presentations outlining their experiences with EDF outreach.

#### 3. NEXT STEPS

The Commission invited NFPs to send suggestions for topics to be addressed at the next NFP meeting, provided information about upcoming ENDR events and about the launch of a new EEN Sector Group 'Aerospace & Defence'.

The next NFP meeting is expected to take place in the second half of September 2022 (date to be confirmed).
