First meeting of the Special Group of National Focal Points for the European Defence Fund

Summary Record

1. Introduction

The Commission organised the first meeting of the Special Group of National Focal Points for the European Defence Fund (NFP-EDF) on 3 December 2021. The meeting took place in a virtual format.

2. Points discussed

The members of the group addressed the following main items during the meeting:

- The status of the Special Group and organisational matters related to the functioning of the group;
- Information about the NFP-EDF web page and wider communication;
- Support to NFPs in terms of training and best practices during 2022;

- Members were informed about the setup and support provided by the Commission to the network of National Contact Points (NCPs) under the Horizon Europe R&I programme.

The Commission informed that revised Guiding Principles and draft Rules of Procedure would be sent to NFP's ahead of the second meeting of the group.
